

VANUATU

UPDATE ON THE EUROPEAN COUNCIL'S RULING



The European council has issued a partial suspension on their visa waiver agreement with Vanuatu. This means current Vanuatu passport holders will not be able to access visa free travels to EU countries and will instead need a visa for the Schengen Areas. The suspension will take effect from May 4th, 2022.

The council has given Vanuatu two months to meet all of EU's reform demands before the cancellation is finalized. If they meet their concerns the suspension will be repudiated. Otherwise, the suspension will be final. The government is working hard to meet these demands which are not unusual as Cyprus and Malta have gone through same in times past..
